### II. CURRENT WORK

Member, Board of Directors - Landbank of the Philippines

The Board of Directors of the Landbank of the Philippines are primarily responsible for approving and overseeing the implementation of Landbank's strategic objectives, risk strategy, corporate governance and corporate values. The Board of Directors is also responsible for monitoring and overseeing the performance of senior management in managing the day-to-day operations of the bank.

- > To perform the above responsibilities, Director Aguelo, in addition to his participationin the regular meetings of the Board of Directors, also performs the following functions:
  - Member, Risk Committee, Landbank of the Philippines
  - Member, Audit Committee, Landbank of the Philippines
  - Member, Agri-Agra Social Concerns Committee, Landbank of the Philippines
  - Chairman, Board of Directors, Masaganang Sakahan Inc. (a wholly-owned subsidiary of the Landbank of the Philippines)
- > Notable Accomplishments:
  - Pushed for the establishment of the Landbank's Agri-Agra Social Concerns Committee
  - Through the Agri-Agra Social Concerns Committee, institutionalized direct lending programs for small farmers and agrarian reform beneficiaries (e.g. Sikat-Saka Program, Agrarian Production Credit Program)
  - Lobbied at the Senate and mobilized support from farmers groups for the extension of the corporate life of Landbank for another 50 years.
  - Raised before the Agri-Agra Social Concerns Committee key issues and concerns of local agrarian reform beneficiaries and their cooperatives. Most notable issues raised were:
    - The LABUCO case which involves the foreclosure of numerous Certificate of Land Ownership Awards (CLOAs) of members of the LABUCO Cooperative by Landbank due to failure of the cooperative to repay its loans. The individual CLOAs of the member-ARBs were used by cooperatives as collateral for loans of the cooperatives. CLOAs which have been held by Landbank for "safe keeping" have been ordered for release.
    - The HARBCO case which involves the plea of the Hijo Agrarian Reform Beneficiaries Cooperative (HARBCO) to be released from a "grossly disadvantageous agribusiness venture agreement/contract (AVA)" which they entered with the former landowner. Said contract has buried the cooperative in debt amounting to more than Php 600 million. Said case became the subject of a Congressional hearing by the House Committee on Agrarian Reform and the DAR is set issue an Administrative Order on AVAs.
    - PANAW-Sumilao MPC case which involves the request of the said cooperative for the revaluation of the land awarded to them under the Comprehensive Agrarian Reform Program (CARP) after they shifted from sugarcane to corn production, which would lower the valuation of the land and, subsequently, the land amortization to be paid by the cooperative. The revaluation process is on-going.
