**RESOLUTION RECOMMENDING TO CANCEL BID  
FOR THE ACQUISITION OF LAMINATED RICE SACKS**

**WHEREAS,** the Bids and Awards Committee of Masaganang Sakahan, Inc. received the request dated February 13, 2017 for the acquisition of 60,000 pcs. of 50 kg. and 20,000 pcs. of 25 kg. laminated rice sacks

**WHEREAS,** the requirement was posted in the PhilGEPS website under Public Bidding from February 21-28, 2017.

**WHEREAS,** after the posting no supplier participated in the Public Bidding.

**WHEREAS,** the requirement were posted for the second (2<sup>nd</sup>) time in the PhilGEPS website from March 11-22, 2017.

**WHEREAS,** after the 2<sup>nd</sup> posting, no supplier participated in the bidding.

**WHEREAS,** the requirement were posted for the 3<sup>rd</sup> time in the PhilGEPS website under negotiated Procurement – Two Failed Biddings (Sec. 53.1) from March 29-April 4, 2017.

**WHEREAS,** after the posting UNINOVUS submitted a quotation for the supply of laminated rice sacks while to (2) suppliers namely VG Multi Products Enterprises and Rodenstock Manufacturing Corporation requested to see the sample of the laminated rice sacks but did not submit a quotation.

**WHEREAS,** MSI BAC requested UNINOVUS to submit their Best and Final Offer.

**WHEREAS,** after submitting their Best and Final Offer, the supply of laminated rice sacks was awarded to UNINOVUS.

**WHEREAS,** MSI BAC requested UNINOVUS to submit Eligibility Requirements.

**WHEREAS,** on May 30, 2017 Mr. Alvin Ong, Operations Manager of UNINOVUS sent a letter informing MSI BAC that they cannot serve the requirement since they cannot comply with the Eligibility Requirements.

**WHEREAS,** the Bids and Awards Committee of Masaganang Sakahan, Inc. **RESOLVES,** as it is hereby **RESOLVED,** cancel bid for the Supply of Laminated Rice Sacks


